HOW IT WORKS

Upon referral to our service, we start with a comprehensive risk and safety assessment in situ with your client. We arrange this with the client and keep you advised throughout our process.

Our assessments involve the client and consider individual risk and safety from a range of different perspectives including home, personal and technology. Depending upon what you and your client identify, we can provide a particular focus on one area of risk and safety or a combination of areas.

We then develop a risk and safety report that recommends a set of tailored interventions to reduce risk and optimise safety for your client. We let you know the approximate cost of the recommended interventions so that you as referrer can secure the appropriate funding for the interventions you approve. Once you have secured funding, we proceed to organise until all interventions have been put in place.

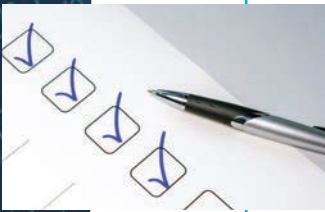
Risk and safety assessment
